#### A. Grant Offer – AIP 54

Mr. Kip Turner briefed the Board. Mr. Turner stated that this is an amendment to the last grant that was discussed in the last Board meeting. Mr. Turner said that there was an additional \$4,500 included in the actual grant and that is to cover reimbursement for the independent fee estimate (IFE). Staff is asking for the Board to amend the authorization for the Chairman to still sign and execute the grant agreement for the new amount and the other agreements that need to be in conjunction with both the City and the County.

Commissioner Wagner made a motion to amend the prior action by the Board authorizing the Chairman to sign the original application to include the authority sign a supplemental piece. Commissioner Ball seconded. Voice Vote. All Ayes.

### B. Grant Offer – AIP 55

Mr. Kip Turner briefed that Board. Mr. Turner stated that this is the second grant that they were anticipating for this year, in the amount of \$2,216,716.00 from the FAA out of the AIP grant entitlement funds along with a State match from CDOT Aeronautics for the amount of \$125,000.00 for AIP 3-08-0027-055-2016 with the purpose of this to be used for an element of the overall design of the replacement runway 11/29 and the remote transmitter receiver (RTR).

Commissioner Taggart moved for the Board to authorize the Chairman to execute the following documents; Grand Agreement 3-08-0027-055-2016, the City of Grand Junction Co-Sponsorship Agreement and the Mesa County Co-Sponsorship Agreement. Commissioner Nelson seconded. Voice Vote. All Ayes
